## TOURNAMENT RULES AND INFORMATION

1. All Entrants must be a member of their local USBC association and TSWBA. **You may enclose your \$1 TSWBA Dues if NOT ALREADY PAID this year.**
2. The tournament shall consist of a **4-woman team event**, a doubles event, a singles event and all events. Three consecutive games shall be bowled in each event. Optional All Events will consist of 9 games. The tournament will be handicapped, and will be based on 90% of 210.  

The 4-member team bowling the highest total pins plus handicap in the team event shall be declared the TSWBA Team Champions; the 2-member team bowling the highest total pins plus handicap in the doubles event shall be declared the TSWBA Doubles Champions; the individual bowling the highest total pins plus handicap in the singles event shall be declared the TSWBA Singles Champion; the individual bowling the highest total pin plus handicap in the 9-game all events shall be declared the TSWBA All Events Champion.
3. Entrants must use their highest Tennessee USBC Certified league average regardless of whether bowled as a member or as a substitute. **ONLY AVERAGES ESTABLISHED THROUGH A LEAGUE CERTIFIED IN THE STATE OF TENNESSEE WILL BE ACCEPTED.** Averages will be in the following order:
  - A. Highest 2010/2011 winter season for at least 21 games (Book average will be accepted as official).
  - B. If "A" does not apply, the highest current average as of March 1, 2012 for at least 21 games.
  - C. If "A" or "B" does not apply, the highest summer league average as of the end of previous summer schedule for at least 21 games.
  - D. All others will bowl scratch.
  - E. USBC Rules 319a-2, 319d and 319e do not apply.
4. After entry has been received, and the dates assigned by the tournament director and are not refused by the team or individual entrant prior to the preparation of the schedule, **NO FEES SHALL BE REFUNDED.**
5. A bowler may **enter** only once in each event (team, doubles and singles). **EXCEPTION:** At the tournament site, a bowler will be allowed to bowl one additional time as a substitute in the team event *and/or* in the doubles event to fill unexpected vacancies. All events will be determined by the bowler's first appearance in any event.
6. Substitutes are allowed when replacement is necessary. **IF POSSIBLE, SUBSTITUTIONS MUST BE MADE ONE HOUR BEFORE SCHEDULED BOWLING TIME.** In case of an emergency, after a game has started, a substitute shall be allowed in the team and doubles events only. The combined scores are to count in either of these events. If no substitute is available, only the actual score of the frames bowled shall count.
7. The lineup will be the same as shown on the entry form. Pacers will not be allowed.
8. Singles are bowled immediately following doubles. If one bowler is late for the doubles event, the entrant present will bowl her singles event first. If her partner has not arrived by the time the singles event is finished, and a substitute is not available, she will be permitted to bowl her games in the doubles event in order to qualify for all events.
9. All prize money will be returned 100%. The prize list shall be compiled on the basis of at least one prize for every seventh entry, including all events. In case of a tie for first place, co-champions will be declared with descending prize money for number of ties being divided equally and duplicate awards given.
10. **Plaques will be awarded to first place team, doubles, singles and all events in both handicap and scratch.**
11. Bowlers are to check in ready to bowl at least 30 minutes prior to the schedule time. Team captains will check in for their team; doubles partners check in together. **USBC MEMBERSHIP CARDS WILL BE REQUIRED WHEN CHECKING IN.** Bowlers without USBC cards may be required to purchase an affiliated membership card at the cost of \$25.00.
12. Only one bowling ball per member will be permitted on the ball return during Tournament competition.
13. **NO FOOD OR DRINK WILL BE ALLOWED IN THE BOWLING AREA. NO ALCOHOLIC BEVERAGES WILL BE ALLOWED DURING TOURNAMENT PARTICIPATION. CELL PHONES MUST BE TURNED OFF OR PLACED IN A SILENT MODE DURING PARTICIPATION.**
14. Bowlers are requested to wear suitable attire when participating in the tournament (no short-shorts, mini skirts, t-straps, tank tops, etc.).
15. Teams wishing to bowl doubles at the same time ***must*** send entries and fees in the same envelope.
16. USBC rules and regulations will govern this tournament.
